Tox-Away Day

The Allen County Department of Environmental Management (ACDEM) has partnered with the City of Fort Wayne to expand ACDEM's weekly "Tox-Away Tuesdays" collection of household hazardous waste (HHW) for Allen County residents to Saturdays 9 a.m. to 2 p.m. The next dates are: September 7 and October 12.

Between now and then, box your chemicals and store them in a safe place, out of reach of children and away from direct sunlight. Do not mix products together or remove labels. Leave all products in their original containers.

NO latex paint is accepted. Latex paint is not hazardous waste and can be placed in your garbage cart. BUT, it must be completely dried out before placing the cans in your bin.

Minimal fees and material limits will apply. Review product guidelines, fees (cash or check only), and directions on their website: bit.ly/2105RK4.

Location: 2260 Carroll Road. You MUST enter the facility from Fort Recovery Road via Lima Road.

What is Your Address?

It is a City Ordinance that every owner of a building on any street is required to place the address numbers of that building in a "conspicuous place on the front of the building."

The Ordinance further states "the numbers shall consist of figures not less than three inches in length, and so made as to be distinctly or easily read."

Failure to place house numbers in a manner described above can result in a fine.

It is important that you comply with the City Ordinance for many reasons, not the least of which is to help Police and Fire departments find your house in an emergency.

Trees Are Coming

Using the Parks Department "Citizens Match Program," 8 new trees will be planted in areas throughout the Esplanade where trees have died or an area is simply sparse. An additional 3 trees will be planted in the triangle bordered by Calhoun, Calumet and Sherwood Terrace.

City Arborist Derek Veit and Don Orban, LPIA Board Secretary and Master Gardner, have chosen trees to enhance the variety and beauty of our neighborhood.

The "Citizens Match Program" allows us to purchase trees that would normally cost \$200 - \$250 each for only \$50 each – and that includes installation by the Parks Department.

The addition of trees will continue the beauty of the Esplanade and Lafayette Place for future generations.

Recycling Schedule

We are on "A" schedule for recycling and our recycle items are picked up in the yellow topped can every other Thursday, with your garbage.

For your convenience, the remainder of our 2019 **recycle dates** are listed below:

August: 29

September: 12 & 26 October: 10 & 24 November: 7 & 21 December: 5 & 19

NOTE: If your garbage or recycle bin is not picked up by sunset on the scheduled day, **call 311** to complain. If you notice your entire street has not been picked up, please tell the 311 Operator.

Talk If You Can – Call If You Must

There are many complaints that are called in to LPIA Board members that can only be resolved by you, as an individual and resident.

If you have a problem with a neighbor, we suggest you "keep it neighborly." Whatever the complaint or situation, **talk** to the offending neighbor **first** and try to handle it in an amicable way. That might be all it takes!

The "311 Call to City Hall" is a sort of "one stop shop" in that they take the actual reports for some things or refer you to the proper agency for others.

There is a menu that will list some of the City departments or issues you want to address. Complaints or problems that address things such as streets, lighting, cars, etc. can all be directed to 311 – and of course trash complaints go here also! Neighborhood Code Enforcement for property issues such as tall grass or weeds, broken windows, unkempt property, etc. is also accessed through 311.

The 311 Operator will give you a control number of your report. Keep this number as a reference of your call as it might take several calls before action is taken.

Always call 911 in an emergency.
