# **Abandoned and Inoperable Vehicles**

Per a City Ordinance, it is illegal to abandon a vehicle on **public or private property**, including dismantled, non-operating, wrecked, or junked vehicles. State law defines an **abandoned vehicle** as, "a vehicle that is three (3) or more model years old and mechanically inoperable, and is left on private property for more than twenty (20) days." If a vehicle is tagged on private property, the owner has 20 days to show that it is operable or the vehicle may be towed and a \$100 ticket could be issued.

An **inoperable vehicle** is defined as a vehicle which cannot be driven/operated upon the public streets for reasons including but not limited to being wrecked, abandoned, in a state of disrepair, or incapable of being moved under its own power.

Additionally, Residential Parking Ordinance 72.23 states that no vehicles are allowed to park on the lawn, on either public or private property. This includes the median between the sidewalk and the street, and definitely NOT on the sides of Lafayette Park.

Call 311 to make a complaint on these issues.

### Talk If You Can - Call If You Must

There are many complaints that are called in to LPIA Board members that can only be resolved by you, as an individual and resident.

If you have a problem with a neighbor, we suggest you "keep it neighborly." Whatever the complaint or situation, **talk** to the offending neighbor **first** and try to handle it in an amicable way. That might be all it takes!

The "311 Call to City Hall" is a sort of "one stop shop" in that they take the actual reports for some things or refer you to the proper agency for others.

There is a menu that will list some of the City departments or issues you want to address. Complaints or problems that address things such as streets, lighting, cars, etc. can all be directed to 311 – and of course trash complaints go here also! Neighborhood Code Enforcement for property issues such as tall grass or weeds, broken windows, unkempt property, etc. is also accessed through 311.

The 311 Operator will give you a control number of your report. Keep this number as a reference of your call as it might take several calls before action is taken.

### Always call 911 in an emergency.
